1. Call to order

The meeting was called to order at 7:28PM by Chair – Doug Bailey.

a. Agenda Adoption - Motion by Devon Fuller/Tracy Wyman to adopt the agenda as presented. **The motion passed unanimously – 4 to zero.**

2. Consent Agenda

a) Minutes of Board of Liquor Control Commissioners Meeting – September 14, 2015

Motion by Devon Fuller/Seth Hopkins to approve the minutes of the September 14, 2015 meeting. **The motion passed with one abstention – Ethan Swift.**

Seth Hopkins asked if a 3rd Class License includes the 1st Class License. Erynn Young Doaner stated they would require separate approvals and the application was submitted for the 1st Class License. Seth Hopkins suggested considering a 1st Class Liquor License as well for the same establishment.

Motion by Seth Hopkins/Tracy Wyman to add Item d) Approve 1st Class Liquor License for Erynn Young Doaner dba Common Ground Restaurant & Pub. **The motion passed unanimously – 4 to zero.**

b) Approve 3rd Class Liquor License for Erynn Young Doaner dba Common Ground Restaurant & Pub

c) Approve Outside Consumption Permit for Erynn Young Doaner dba Common Ground Restaurant & Pub

d) Approve 1st Class Liquor License for Erynn Young Doaner dba Common Ground Restaurant & Pub

Motion by Devon Fuller/Seth Hopkins to approve the 1st Class Liquor license, 3rd Class Liquor License and Outside Consumption Permit for Erynn Young Doaner dba Common Ground Restaurant and Pub.

Ethan Swift stated the outside consumption hours indicate 2PM to 10PM and questioned if this is the same as the current hours open. Ms. Doaner stated the restaurant hours will be 2PM to 9PM, however, the application hours of 2PM to 10PM were submitted to allow people to finish their drinks. The current hours are 11AM to 10PM and the request is fewer hours than the current hours. Ethan Swift also confirmed the completion of the 1st Class seminar. Ms. Doaner stated it was completed in February 2015 and noted she has been a bartender for 15 years.

The motion passed unanimously – 4 to zero.
