Anna Scheck noted the current Brandon Land Use Ordinance already has regulations for this type of issue under Section 627 - Outdoor Storage of Junk. Jeff Guevin stated there will be further review of the uses at a subsequent meeting. Continued discussions of the Brandon-Base Code and review of the Brandon Land Use Ordinance will be done at the next meeting.
