Fees and Conditions:

Fees for Itinerant Vendor Permit are payable in full upon application and will be Refunded if the application is denied.

Vendor Permit - \$25 per day, ~~\$150.00~~^{100.00} per year /365 days from date of issue.

Rules and Conditions of Vendor's

- Permit shall be displayed at all times.
- Vendor will not interfere with pedestrian traffic or the flow of vehicular traffic.
- Vendor will provide a trash receptacle and police the area for which he is responsible. Grease, ash or any other form of refuse will not be discharged on to any street or sidewalk or in any storm drain.
- Vendor will be responsible for his/her employees ensuring that they comply fully with this ordinance.
- Vendor's cart, stand or vehicle will remove from the public street or sidewalk at the close of business each day.
- Vendor will inform the Administrative Officer of any change in location.

I hereby certify that the information provided on this application is true and complete to the best of my knowledge and belief and I understand that any false or incomplete statements can lead to the revocation of this permit. I also authorize the Brandon Police Department to release any information to the Town Manager relevant to the truth of this application. I understand that failure to abide by this ordinance and all other ordinances pertaining to vending may lead to revocation of this permit
